

# Specialist Course in Integrative Couple Therapy

Apply now, start February 2026!

**In its 36th year, this renowned course is open to counsellors and psychologists wanting to develop rigorous knowledge and specialist skills for working with couples.**

The course uses an integrative therapeutic approach, which is strongly grounded in evidence-based models and contemporary practice.

It equips participants with the skills and practical experience to respond flexibly to couples' particular needs, world views and situations.

## Theories and modalities

Recognising the limitations of using a single theoretical model, our course provides training in a range of theories and practices, including:

- Attachment Theory
- Psycho-Dynamic, Systemic and Integrated Behavioural Theories
- Emotionally-Focused Therapy
- Neurobiological-informed practice.

It incorporates research findings by Gottman and considers emerging ideas and practice trends.

The course's 'Therapeutic Self' module enhances participants' understanding of what shapes them as therapists, enabling them to remain reflective in what is often an emotionally charged field.

## Structure

### Duration:

1 day a week, for 5 months

### Delivery:

In-person in Camberwell, Victoria

The course is also an accredited component of the Swinburne University Master of Social Science (Couple Counselling) at the second year level.

## Outcomes

Graduates will have specialist knowledge and emerging skills to assist couples experiencing a range of challenging issues.

## Teaching methods

- Interactive presentations, supported by relevant readings.
- Case discussions and live demonstrations to consolidate learnings and apply theories and methods.
- Workshops with opportunities to practice couple therapy skills.

Course content encompasses societally relevant topics including:

- neuroscience, emotion and attachment-informed therapy for couples
- sex and intimacy
- affairs and betrayals
- gender and diversity
- separation and loss
- re-partnered couples and blended families
- working with couples experiencing high conflict
- assessing for intimate partner violence and coercive power and control
- working inclusively with LGBTIQ people and their relationships
- neurodivergence in the couple space.

## Course fees

\$5,500. Instalment options are available.

A \$1,500 deposit is required to secure enrolment.

## Entry requirements

Applicants are required to:

- have appropriate tertiary qualifications in social services and a minimum of one year's face-to-face counselling experience, and
- attend an interview prior to acceptance into the course.

## Membership and accreditation

The course and post-course options can be applied towards meeting prerequisites for registration and accreditation with the College of Relationship Counselling in PACFA (Psychotherapy and Counselling Federation of Australia).

Course completion, clinical internship and clinical supervision and workplace experience can be applied towards postgraduate tertiary degree programs with Swinburne University and the University of Melbourne.

For students completing the Swinburne University Master of Social Science (Couple Counselling), the course has industry accreditation with the Australian Counselling Association.

Membership of professional counselling organisations provides eligibility for a provider number with some private health insurance funds.

## Post-course options

- **12-month clinical internship**
- **Clinical supervision and workplace experience**

Graduates can choose to complete an additional 12-month supervised internship at a Relationships Australia Victoria (RAV) centre or through another RAV-nominated provider.

We encourage and support graduates to continue their learning, and strengthen their skills and experience in the specialised field of couple counselling.

Placements are designed to accommodate and maximise learning needs in real-life work situations, enabling interns to apply their knowledge and skills gained during the course.

During the 12-month placement interns are required to carry a case load of 4 to 5 clients per week, with a minimum of 2 appointments being conducted after hours.

Interns will primarily provide services to couples, but may also also work with some individuals presenting with relationship difficulties.

Each training intern is allocated a training supervisor for weekly individual supervision. This includes reviewing recorded audio and/or video clinical sessions.

The supervisor is responsible for the training intern's induction, as well as allocation, day-to-day direction and professional supervision of all casework undertaken.
